## Round-up of the year 2019/20

2019/20 has been another fantastic year for the team at SPA and our Partners throughout Scotland, with the undoubted highlight being the achievement of our milestone 100th registered partner who joined us in December. We are delighted with our progress, especially as it is only four years since our inception. We now have partner organisations the length and breadth of the country, all benefiting from the savings and shared support we are delivering daily through our collaborative activities.

**Collectively, our partners procured over £237m of works across all manner of building and construction projects, from a roof replacement project for NHS Inverclyde to Cherry Tree Nursery in Dalmilling.**

This year saw the expansion of our range of procurement solutions, with the launch of our first Dynamic Purchasing System (DPS).

Reacting to feedback from our partners and suppliers gained during our extensive pre-tender engagement for the Whole

House Refurbishment and Associated Works (WH2) Framework, we decided to split the offering into a Framework and DPS.

This was to ensure the best solution for all partners, regardless of location or contract size. Thank you to everyone who attended our engagement events, your feedback was invaluable and has helped to shape this innovative new procurement solution.

In addition to WH2, we launched our Fire Safety frameworks – FS1-C Fire Safety Consultants and Risk Assessors and FS1-P Passive Fire Protection, which provide access to high-quality companies supplying a range of passive fire protection and fire consultancy services. These new additions were added to the range alongside the refresh of our highly successful N8 Energy Efficiency and Associated Works framework, which includes technological improvements that were introduced as a result of partner feedback.

Whilst striving to ensure our products and services reflect the requirements and needs of our partners, we have also worked hard to strengthen our strategic relationships this year by formalising our partnership with Scottish Federation of Housing Associations (SFHA) and entering into a new partnership with Supplier Development Programme (SDP). We are looking forward to working closer with both organisations to ensure our products and services support their members aims and aspirations.

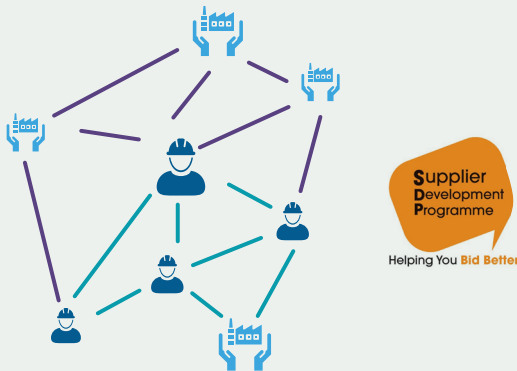

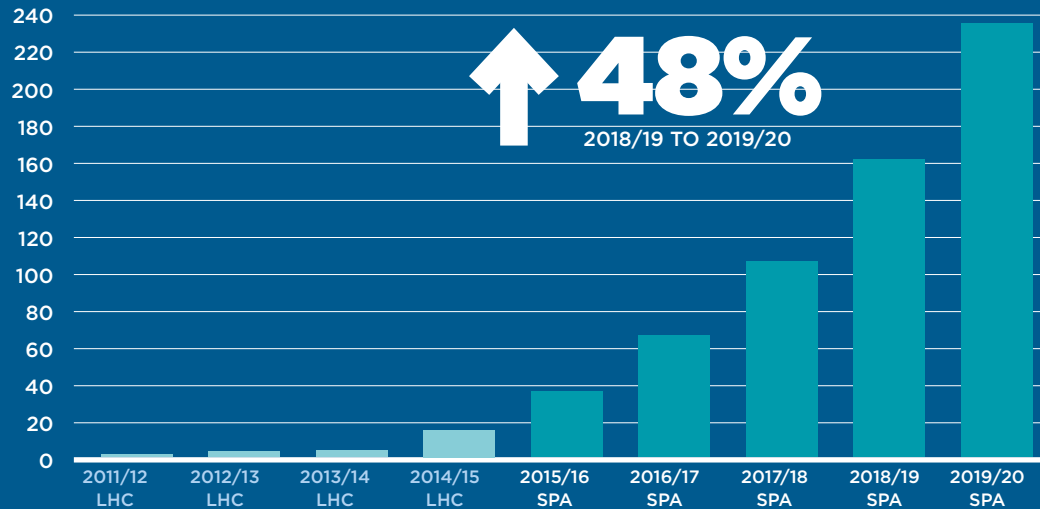

## SPA Community Benefit Fund

It has been another busy and successful year for SPA's Community Benefit Fund with an increase in Executive Committee Member communication. This has been the third year of working with Founder Partner organisations and their community contacts. Good working relationships have been built over previous years which makes for an easier process.

### Headlines from Community Benefit 2019/20:

- A total of £130,000 of a possible £140,000 was distributed to a variety of projects across Scotland
- £10,000 was rolled over to 2020/21 to allow for River Clyde Homes to identify the most effective use of the funding
- A total of 15 projects received funding
- A total of £93,788 match funding achieved so far
- Partnership with 11 community groups
- 18,843 anticipated beneficiaries
- 13,879 meals provided to South Ayrshire Holiday Hunger Scheme
- 81 people completed family based and accredited First Aid courses

### Impact of Covid-19 on projects and reporting

Very early on in the pandemic, Lintel Trust and SPA recognised the impact that lockdown was likely to have on funded projects already being delivered and those community-based projects that were due to start. The vast majority of funded projects involve person-to-person contact, particularly those addressing social isolation.

In agreement with SPA, we were able to reassure ECMs that we understood that priorities had to change and there would be inevitable delays to both project delivery and evaluation.

We also offered the option for organisations to re-purpose their funding to help their communities address more pressing needs caused by the pandemic. Some organisations have put their projects on hold in the hope that they will still run in the future. Others have used their funding to support local foodbanks.

Reduced staffing due to furloughing has also impacted the number of evaluation reports received and we have been sensitive to the needs of SPA partner organisations.

As such, the full detail of Lintel Trust's annual CBF report will not be available until all feedback has been received.

### Linstone Housing Association – First Aid Training

- Family First Aid Course delivered to 27 adults and 19 children

### Linwood Youth SPACE

One jointly funded summer project supported with 10 local young people working alongside Create Paisley, to deliver the SPACE Local Partnership project. They identified the lack of facilities for 13-19 year-olds, found a suitable youth space to develop for young people to congregate and worked on developing a short film to make their case. Funding is now being sought to enable the space to be transformed.

## SPA Community Benefit Fund

### Wheatley Group – Dolly's Parton's Imagination Library

Wheatley Foundation has committed to this popular programme aimed at addressing inequalities through the provision of free books to children aged nought to five years in their communities.

Scottish Government research shows that children living in the most deprived areas are six to 13 months behind their peers in problem solving at age five. They are 11 to 18 months behind their peers in expressive vocabulary at age five. By the age of 15 those from more deprived areas are likely to be around two years of schooling behind their peers.

Across Wheatley Group subsidiaries there are over 33,000 socially rented homes located in the lowest 15% SIMD areas. They deliver books to communities in four local authority areas already. This funding will allow them to expand into new, more rural areas with an anticipated 750 families benefitting.

Parent feedback so far:

*“The girls love receiving post in their name and love reading their books with their Dad and myself.”*

*“My child enjoys receiving these books and has loved every single one. She also enjoys receiving post of her own that has her name on.”*

### Clyde Valley Apprenticeship Support

The CBF assisted the first three female joinery Modern Apprentices in Scotland. Helena and Sarah have started four year apprenticeships with Timetra.

*“From the trainee's point of view, the grant funding has not only given Sarah and Helena the opportunity to pursue their dream of working in the Construction Industry, but it has also given them the ability to demonstrate that there is a place within the modern industry for young women.”*

*“From our Company's viewpoint, at a time when the Industry was relatively flat, even before the onset of the Covid-19 Virus, this type of funding is the difference between enrolling new apprentices and postponing any new intake for a further year. Our apprenticeship scheme is a core part of our values as a Company, and this grant has been invaluable in assisting us to continue it.”*

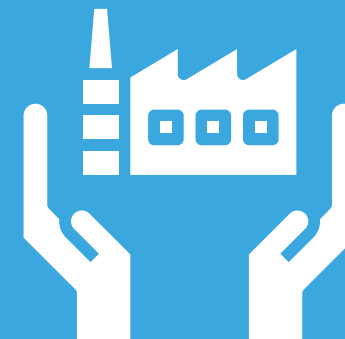

## Strategic partnerships

### SFHA Partnership

SFHA Partnership: Lesley Anderson (SPA)  
and Sally Thomas (SFHA)

Since our formation in 2016 we have been working together with the Scottish Federation of Housing Associations (SFHA).

This collaboration saw the creation of the Procurement Advisory Service, which improved public value through better understanding and implementation of Scottish procurement regulations. SPA provided the financial backing so that SFHA members could access the service free of charge.

Lesley Anderson, SPA Head of Procurement, said:

*“Since 2016, we have been working together with SFHA to support its members and the wider public sector.”*

*We are proud of the work we have done which has improved public value through better understanding and implementation of Scottish procurement regulations.”*

This service included an enquiry function, guidance, seminars and workshops, and procurement roadshow events throughout Scotland. Ninety per cent of RSLs throughout the country interacted with the service, and over 1,000 individuals utilised it.



Sally Thomas, SFHA Chief Executive, said:

*“By partnering with SPA, SFHA ensured that all our members throughout Scotland could gain access to the Procurement Advisory Service.”*

*SPA recognised the importance of procurement advice and support for the sector before the regulations came into force.”*

In January of this year, SPA and SFHA met to discuss the possibility of a second phase of procurement training for all our members and what would need to be covered. In support of this aim, Lesley Anderson and Graham Collie from SPA, chaired the first renewed SFHA Procurement Forum in partnership with Stacey Dingwall, Policy Lead for SFHA. Due to the current climate, we are reviewing what form this training will take.

**In 2019, we joined the Supplier Development Programme (SDP) as an affiliate member. At SPA we are committed to supporting the local economy through our frameworks and dynamic purchasing systems and we are looking forward to working in partnership with SDP.**

We will now be able to utilise the SDP to alert the market of upcoming contract and framework opportunities to more than 14,500 registered micro, small, medium and supported businesses.

Engaging with as many companies as possible throughout the country, in particular SMEs, is crucial to the development of our procurement solutions. At SPA we ensure that all our frameworks and dynamic purchasing systems provide the best possible offerings for all our partners.

Our partnership with SDP will provide early engagement and invaluable support for SPA and we value the great work they undertake for Scottish suppliers.

Speaking in advance of a presentation to the SPA Executive Committee on 5 November, Gillian Cameron, Supplier Development Programme Manager, said:

***“Our work to deliver free tender training to Scottish-based SMEs will encourage their involvement in future frameworks that are advertised by the Scottish Procurement Alliance.***

***SDP has outlined how we can work together with SPA on pre-tender engagement in the future, and I know that our partnership will mutually benefit SPA partners as we move forward with upcoming opportunities.”***

## Understanding the market

### The story of SPA's new Whole House Refurbishments and Associated Works procurement solution (WH2)



**Our newest procurement solution was identified in conjunction with our Partners who highlighted the need for a broader offering, in regards, to supporting their housing requirements and meet the Governments new Housing to 2040 targets.**

Following on from our successful New Build Housing framework, there was a requirement for a compliant procurement route to, not only maintain the new builds going forward, but improve and repurpose the existing stock. So, the team began to design a one stop shop procurement solution for our Partner's housing maintenance needs.

When we begin to develop a new framework for our Partners, we liaise with them to discuss their future requirements to ensure any proposed offering will meet their requirements.

For WH2, we held 10 pre-tender engagement seminars for Partners and Suppliers throughout the country, including an online session.

Every session garnered invaluable feedback and helped to shape the Whole House procurement solution. For example, we learnt that regions outwith the central belt weren't being serviced by local suppliers so it became clear that a dynamic purchasing system (DPS) approach would be best suited to the outer lying regions. Everything we do at SPA is Partner led, as we are a not for profit organisation, our ethos is to support our Partners not shareholders.

Our Whole House Refurbishment and Associated Works procurement solution is a blended product with framework and DPS dependent on your region.

Whole House is a holistic product offering to upgrade almost any aspect of the housing property – inside and out.

It covers a comprehensive list of works including electrical upgrading, painting and decorating, disabled adaptations, new kitchens and bathrooms, and a multi-disciplinary offer.

Our framework terms specifically allow for emergency works, where required,

therefore contracts can be implemented quickly to ensure quick turnaround times for urgent requirements. Our Call Off terms allow the option to Direct Award or carry out a Mini Competition dependent on your project specific requirements.

## Growing the SPA team

Reiss Stewart is currently studying a BA Honours in Business Management through the Graduate Apprenticeship scheme whilst working as an Administration Officer for SPA.
